The only way to change or add to this agreement is to be done in writing and signed by all parties. All waivers must be written and signed as well.

**RESERVATION:** A signed contract and reservation fee are required to reserve the specified wedding date.

**PRE-EVENT CONSULTATION:** The parties agree to a pre-event consultation (either by phone or meeting) two to three weeks prior to the event date in order to finalize the actual shooting times, locations, and clients request list (in writing). In the event that the bride or groom arrive late, Evantide Photography will not be held liable for failure to take desired photographs.

**COOPERATION:** All parties agree to kindly cooperate and communicate so we can get the best possible result on the day of the wedding. Every effort will be made to capture all of your guests that have joined you in celebrating. Evantide Photography will not be held liable if we are not able to photograph desired people if there is no one to assist in identifying or gathering people for photographs.

**SHOOTING TIME:** The photography schedule and methods are designed to accomplish the goals and wishes of the client in a manner enjoyed by all parties. The client and Evantide Photography agree that kind cooperation and punctuality are essential to that purpose. The photography will commence at the scheduled start time.

**HOUSE RULES:** The Photographers are limited by the guidelines of the ceremony official or reception site management. The client agrees to accept the technical results of their imposition on the photographers.

**IMAGES AND COPYRIGHTS:** Photographs produced by Evantide Photography are protected by Federal Copyright Law (all rights reserved). The limited copyright ownership of the resulting images will be transferred to the client under the following conditions:

1. The images are the property of the client for personal use and for the purposes of the reproduction and giving of photographs to friends and relatives.
2. The client must obtain written permission from and compensate Evantide Photography prior to the client or its friends and relatives publishing or selling the photographs for profit.

**MODEL RELEASE:** In exchange for photographic services received, I hereby give permission to Evantide Photography photographers to use my name and photographic likeness in all forms and media for advertising, trade and any other lawful purposes.

**LIMIT OF LIABILITY:** Evantide Photography warrants and declares that every effort will be made to provide high quality photographic services. In the unlikely event that the photographer is injured or becomes too ill to photograph the event, Evantide Photography will make every effort to secure a replacement photographer. If the situation should occur and a suitable replacement is not found, responsibility and liability is limited to the return of all payments received for the event. Evantide Photography takes the utmost care with respect to the images and equipment. In the unlikely event that a catastrophic mechanical failure should occur to Evantide Photography's equipment and is unable to provide the client with the agreed upon photographic services and/or products, Evantide Photography agrees to return all payments received for the event. Evantide Photography and the client agree that Evantide Photography is not responsible for any other damages, emotional or otherwise.

Evantide Photography requires a \$500.00 deposit to hold a date. The balance shall be received by the wedding date. Wedding proofs and negatives will be available 6-8 weeks after the wedding date.
